#### Treasurer's Report/Financial Secretary's Report

#### **Business in Process**

- <u>Audit Report</u> Marc will work with Mickey on many of the financial exception items. Karl will review other items.
- 2015 Elected Council Members Karl Florian, Cory Phillips, Santiago Saldana, and Charlene Wellborn are our newly elected council members, effective January, 2015. Lee Ann Pace is the alternate in the event of a vacancy. They have been invited to the November & December council meetings to help in the transition to next year. Election of the 2015 Council officers will be at the December, 2014 meeting. Installation for the 2015 Council will be on January 4, 2015.

#### **New and Upcoming Business**

- January 2015 Committee Changes When the new committee structure was established, we agreed to give it 18 months to 2 years before making any changes in our by-laws. Concern has been expressed that changing committee members in January would be disruptive. Some committees will ask members to wait until March, 2015, to make changes in membership. The Endowment and EECC committees are prescribed in the church by-laws and can make changes as they have a need. It was felt that since we don't have updated time and talent surveys at this time, any changes may mean committees are left with vacancies.
- Columbarium Policy Paul Halvorson has been overseeing this committee. We currently have a couple interested in purchasing a niche. One of our former members has requested a refund on their niche. Policy shows that we have no obligation to a refund. Council feels that we should stand by our policy at this time, and we will reconsider a refund if policy changes are made. No action was taken by Council. Paul will respond by letter to the request.

- Kathy Knecht and Pastor Laura will be working on 2015 offering designations and we will discuss at the November meeting.
- Kathy would like committee meeting dates so that she can attend and can address any questions about filling vacancies.
- Council Retreat we need to define our purpose and when it will be. Ideas are wanted and welcomed.
