Share Our Ministries:

- <u>EECC</u> Charlene stated that there is an ongoing list of projects that need completion. She was questioning where funds come from and/or who is responsible for decisions in this process. Many of the quotes for fixes are in connection with the Health Dept. criteria/exceptions. (Approx. \$1,000 for materials, and possibly Epiphany Builders doing some of the labor.)
